IMPORTANT NOTICE REGARDING **COUNTERFEIT PRODUCTS** BEARING SOUTHERN CABLE'S TRADEMARKS

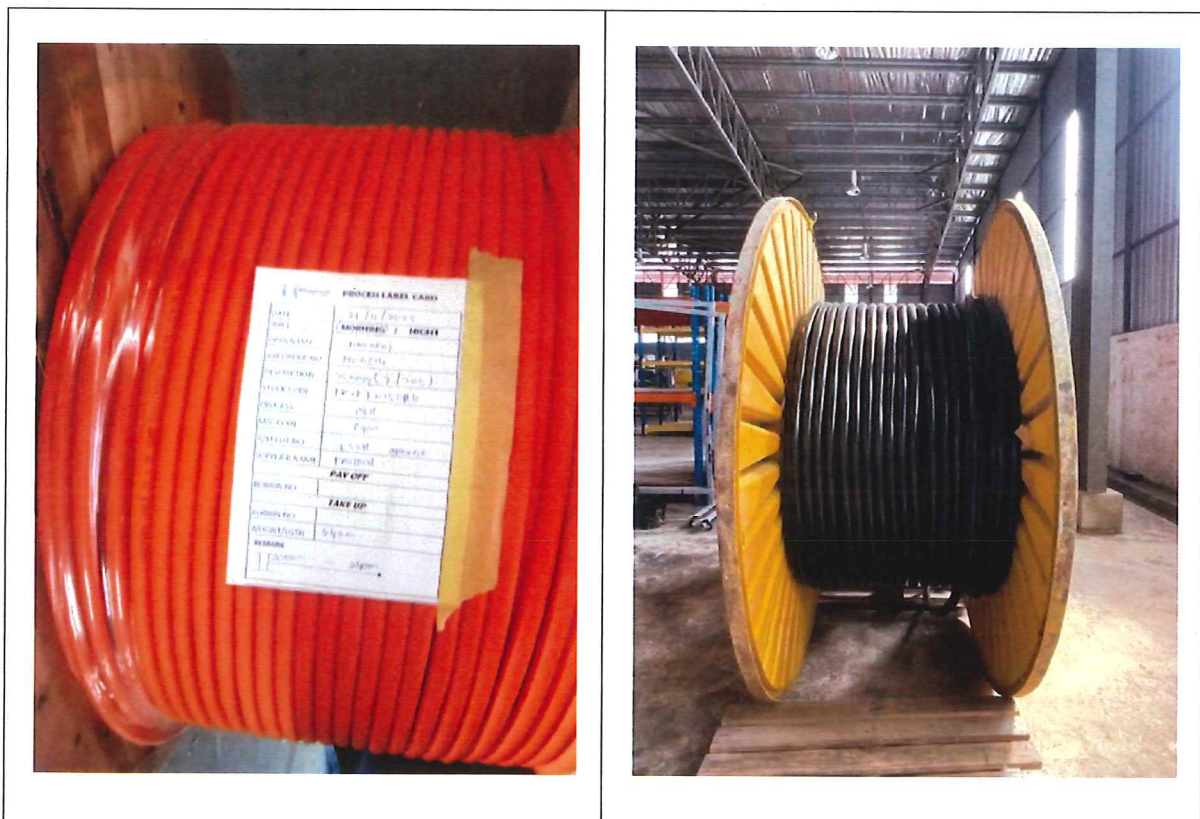
This Notice is published pursuant to the Judgment of the High Court of Malaya at Kuala Lumpur dated 9 June 2026 in Civil Suit No. WA-22IP-56-07/2024.

The High Court has determined that certain electric cables, wires, wooden cable drums and other goods manufactured, supplied, distributed or sold by **PROTECH BUILDERS SDN. BHD.**, **MAGNUM CABLE SDN. BHD.** and **SHIFONG ALLOY WIRE SDN. BHD.**, bearing the registered trademarks of **SOUTHERN CABLE SDN. BHD.** ("**Southern Cable**"), were counterfeit products and were not genuine Southern Cable products. The Court further held **WONG CHAN WAH** and **TUI KIM CHUAN** jointly and severally liable for trademark infringement, passing off, unlawful interference with Southern Cable's trade, and conspiracy to injure Southern Cable.

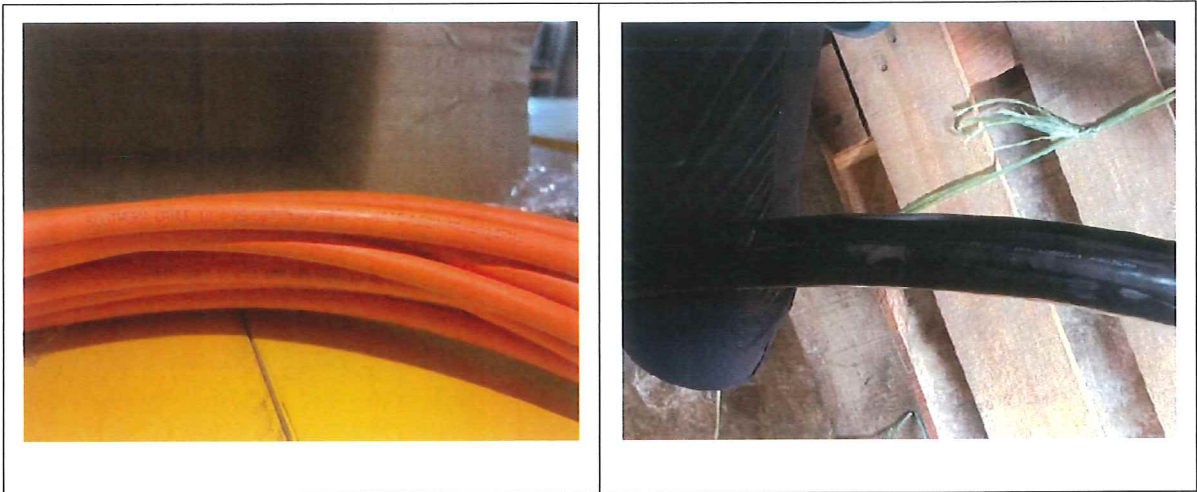

We, **PROTECH BUILDERS SDN. BHD.** (Company No. 200101006831 (542587-T)) ("Protech"), **MAGNUM CABLE SDN. BHD.** (Company No. 200701023062 (781077-V)) ("Magnum Cable"), and **SHIFONG ALLOY WIRE SDN. BHD.** (Company No. 200701001475 (759473-M)) ("Shifong Alloy") (collectively referred as "**Corporate Defendants**"), **WONG CHAN WAH** (NRIC No. 610911-02-5873), and **TUI KIM CHUAN** (NRIC No. 550325-05-5445) (collectively referred as "**Individual Defendants**"), hereby publicly and unreservedly apologise to **SOUTHERN CABLE SDN. BHD.** (Company No. 199301013800 (268538-U)) ("Southern Cable"), its directors, management, employees, business partners, customers and the general public.

Pursuant to the Judgment of the High Court of Malaya at Kuala Lumpur dated 9 June 2026 in Civil Suit No. WA-22IP-56-07/2024, it was determined that the Corporate Defendants had, without the authorisation of Southern Cable, manufactured, stocked, supplied, distributed, sold, offered for sale and/or promoted electrical cables, wires and/or wooden cable drums bearing Southern Cable's registered trademarks, including Trademark Registration Nos. 2017066582 and 08013082, as reproduced below:

The High Court had also pierced the corporate veils of the Corporate Defendants to hold the individual Defendants liable for the acts of the relevant Corporate Defendants.

We acknowledge and accept the findings of the High Court that such conduct constituted infringement of Southern Cable's trademark rights, passing off, unlawful interference with Southern Cable's trade and conspiracy to injure Southern Cable.

We further acknowledge that there are products bearing Southern Cable's trademarks, or trademarks identical or confusingly similar thereto, which were supplied, distributed, sold, offered for sale and/or promoted by us without Southern Cable's authorisation, which are counterfeit products and are not genuine Southern Cable products.

We recognise Southern Cable as the lawful proprietor of the aforesaid registered trademarks and the exclusive owner of the goodwill, reputation and intellectual property rights associated therewith. We regret the harm, loss and damage caused to Southern Cable and withdraw any representation, implication or suggestion that our products, business operations or activities were authorised, endorsed by, affiliated with or connected to Southern Cable.

We have undertaken and will continue to undertake all necessary measures to cease such activities, including the withdrawal and recall of counterfeit products from the marketplace which are in our possession, custody or control, and to ensure that any Southern Cable products procured and/or supplied by us in the future are genuine products obtained through authorised and lawful supply channels.

Members of the public, customers, contractors, consultants, developers and purchasers are advised to exercise caution and to obtain Southern Cable products only through Southern Cable, its authorised distributors and approved supply channels.

Kami, **PROTECH BUILDERS SDN. BHD.** (No. Syarikat: 200101006831 (542587-T)) ("Protech"), **MAGNUM CABLE SDN. BHD.** (No. Syarikat: 200701023062 (781077-V)) ("Magnum Cable"), dan **SHIFONG ALLOY WIRE SDN. BHD.** (No. Syarikat: 200701001475 (759473-M)) ("Shifong Alloy") (secara kolektif dirujuk sebagai "**Defendan-defendan Korporat**"), **WONG CHAN WAH** (No. K/P: 610911-02-5873), dan **TUI KIM CHUAN** (No. K/P: 550325-05-5445) (secara kolektif dirujuk sebagai "**Defendan-defendan Individu**"), dengan ini secara terbuka dan tanpa sebarang syarat memohon maaf kepada **SOUTHERN CABLE SDN. Selaras dengan Penghakiman Mahkamah Tinggi Malaya di Kuala Lumpur bertarikh 9 Jun 2026 dalam Guaman Sivil No. WA-22IP-56-07/2024, telah diputuskan bahawa Defendan-defendan Korporat telah, tanpa kebenaran Southern Cable, mengilang, menyimpan stok, membekalkan, mengedar, menjual, menawarkan untuk dijual dan/atau mempromosikan kabel elektrik, wayar dan/atau dram kabel kayu yang memaparkan cap dagangan berdaftar Southern Cable, termasuk Cap Dagangan No. Pendaftaran 2017066582 dan 08013082, seperti yang dipaparkan di bawah:



Mahkamah Tinggi turut menembusi tabir korporat Defendan-defendan Korporat bagi memegang Defendan-defendan Individu bertanggungjawab terhadap tindakan Defendan-defendan Korporat yang berkenaan.

Kami mengakui dan menerima dapatan Mahkamah Tinggi bahawa tindakan tersebut merupakan pelanggaran hak cap dagangan Southern Cable, perbuatan *passing off*, campur tangan yang menyalahi undang-undang terhadap perdagangan Southern Cable serta konspirasi untuk mencederakan Southern Cable.

Kami selanjutnya mengakui bahawa terdapat produk yang memaparkan cap dagangan Southern Cable atau mana-mana cap dagangan yang sama atau mengelirukan serupa dengannya, yang telah dibekalkan, diedarkan, dijual, ditawarkan untuk dijual dan/atau dipromosikan oleh kami tanpa kebenaran Southern Cable, yang merupakan produk tiruan dan bukan produk tulen Southern Cable. Kami mengiktiraf Southern Cable sebagai pemilik sah cap-cap dagangan berdaftar tersebut serta pemilik eksklusif nama baik, reputasi dan hak harta intelek yang berkaitan dengannya.

Kami kesal atas kerugian, kehilangan dan kerosakan yang telah dialami oleh Southern Cable serta menarik balik sebarang representasi, implikasi atau tanggapan bahawa produk, operasi perniagaan atau aktiviti kami telah diberi kuasa, disahkan, mempunyai kaitan atau berhubung dengan Southern Cable.

Kami telah mengambil dan akan terus mengambil segala langkah yang perlu untuk menghentikan aktiviti tersebut, termasuk menarik balik dan memanggil semula dari pasaran semua produk tiruan yang berada dalam milikan, jagaan atau kawalan kami, serta memastikan bahawa mana-mana

produk Southern Cable yang diperoleh dan/atau dibekalkan oleh kami pada masa hadapan adalah produk tulen yang diperoleh melalui saluran bekalan yang sah dan dibenarkan.

我们，**PROTECH BUILDERS SDN. BHD.**（公司编号：200101006831 (542587-T)）（简称“Protech”）、**MAGNUM CABLE SDN. BHD.**（公司编号：200701023062 (781077-V)）（简称“Magnum Cable”）及**SHIFONG ALLOY WIRE SDN. 高等法院亦揭开了公司被告的公司面纱，并裁定个人被告须就相关公司被告的行为承担法律责任。

我们承认并接受高等法院的裁决，即上述行为构成对南方电缆商标权的侵犯、不正当竞争、非法干涉南方电缆的贸易以及串谋损害南方电缆的利益。

我们进一步确认，由我们在未经南方电缆公司授权下所供应、分销、销售、提供销售和/或推广，并带有南方电缆公司商标或与其相同或近似商标的产品均为假冒产品，并非南方电缆公司的正品。

我们承认南方电缆公司是上述注册商标的合法所有者，也是与其相关的商誉、声誉和知识产权的唯一所有者。

我们对南方电缆公司因此遭受的损害、损失和伤害深表遗憾，并撤回任何关于我们的产品、业务运营或活动已获得南方电缆公司授权、认可、与其有关联或与之相关的陈述、暗示或建议。

我们已采取并将继续采取一切必要措施，制止此类活动，包括将所有处于我们持有、保管或控制范围内的假冒产品撤出市场并予以召回，同时确保我们未来采购和/或供应的任何南方电缆公司产品均为通过合法及获授权的供应渠道获得的正品。
